

Carbon Management Policy



“Mitigating the greenhouse gases emitted into the atmosphere through company activities, and supporting emissions abatement projects.”

Solo Service Group Limited recognises the importance of reducing our contribution to global warming by minimising the greenhouse gas (GHG) emissions associated with our organisation. To contribute to the national goal of net zero emissions by 2050, we are committed to reducing scope 1 & 2 emissions to achieve carbon neutrality by 2030 and to reduce scope 3 emissions to Net Zero by 2040. We will continually reduce the GHG emissions associated with our organisation by measuring our baseline emissions, planning and discussing potential actions towards reducing our contribution to GHG emissions and proactively implementing effective measures to reduce emissions before reporting the efficacy of any actions taken.

Solo Service Group utilises an Environmental Management System that is accredited with BS EN 14001:2015 certification. All of Solo Service Group employees, suppliers and contractors have a role to play in implementing and continually developing our carbon management objectives across the organisation directly, at customer locations and within local communities.

Key Carbon Management Objectives:

Reduce our scope 1 emissions by:

- Implementing an energy management system to monitor and review the energy consumption of our facilities.
- Encouraging staff to conserve energy where possible within the workplace.
- Converting to a Zero Emissions & ULEV fleet including fully electric vehicles where feasible.
- Investing in renewable energy where feasible at our facilities to generate clean energy.

Reduce our scope 2 emissions by:

- Training and developing all of our staff to consider the carbon emissions associated with their energy consumption outside of work.
- Procuring electricity contracts backed by Renewable Energy Guarantee of Origin.

Reduce our scope 3 emissions by:

- Developing a partnership approach with our contractors, suppliers, customers and their local communities on reaching our shared GHG emissions reduction goals.
- Working with our supply chain on reducing the emissions associated with logistical activities.
- Considering the ‘waste management hierarchy’ and implementing circular economy principles in order to reduce our strain on the planet’s resources.
- Setting emissions reduction targets/objectives for ourselves and our supply chain.
- Employing a local workforce and prioritising the procurement of domestically manufactured products where feasible.
- Reviewing our emissions reduction programme annually against best practises for the industry.
- Using cleaning products with a minimal environmental footprint through reduced packaging/ innovative product design.
- Considering the UK’s “Net Zero Strategy” by minimising greenhouse gas emissions associated with business operations and offsetting associated emissions where appropriate.

Solo Service Group directors and senior management are committed to ensuring the implementation, review and continual improvement of its carbon management policy in order to progress towards a net zero business strategy.
